The network service fee covers the following services:

- We transfer electrical energy from the production plant to the customer
- We meter electricity consumption and production
- We are responsible for the round-the-clock outage service of network operations
- We take care of network upgrades and maintenance

The electricity network services contract can be terminated in accordance with the terms of network service.

Good to know about electricity tax

In connection with the network service fee, electricity tax is charged and remitted to the state. Electricity tax includes the electricity excise duty and the strategic stockpile fee. All customers are automatically included in electricity tax category 1, unless they have reported otherwise. Companies operating in the manufacturing industry, mining industry, excavation or professional greenhouse cultivation sectors can be in electricity tax category 2, among others. A written declaration on the operations in tax category 2 must be sent to the network company.

Fuse-based distribution tariffs

The selected product can be exchanged for another product once a year. In retrospective corrections to invoicing, when Elenia also invoices for the electricity vendor's share, the price applied shall be the Nordic electricity exchange's Finnish area price for each trading period to be corrected.

General electricity

The product is suitable for customers who mostly use electricity during the daytime. The form of heating is usually other than electricity. The distribution fee remains the same day and night throughout the year. The general electricity product is also applied to temporary use of electricity, for example occasions and events.
